Safeguarding Focus: Online

As children may get new devices soon it's vital they, and you, know how to keep themselves safe online.

The NSPCC have a quiz at Online safety quiz | NSPCC that is well worth doing as a family. They also have a range of Christmas cards, decorations and advent calendars that will support the vital work they do. Their website has wealth of information to help parents support children at different ages with their use of technology, including a tool to help answer the question—is my child ready for their first mobile phone?



internet matters.org Internet Matters have step-by-step instructions on how to enable privacy / security settings on X, Tik Tok, Snapchat and many others apps. On top of that they have a Digital Family Agreement that is designed to help your family agree on ground rules for use of devices in and out of the home. If you need personalised advice, they are there to help you. If you want to know more about apps before you download them, they have specific information for you on what the app does, whether

there are in-game purchases and other facts you need to make a family wide decision.

The UK Safer Internet Centre has a Parents guide to technology, everything from laptops to Smart Speakers. Should you have any concerns about content you or your family have seen online the National Crime Agency CEOPS unit has a reporting tool online, accessing Child Protection Advisors. They also have a range of information about keeping yourself or a child you know safer from online child sexual abuse, including new guidance on financially motivated sexual exploitation.





Children should also be assured that Childline is there for them 24/7 on 0800 1111, via their 1-2-1 chats with more guidance and support on their website.
